# Airtel signs Up IBM to Back Invented Calls

**Cos expected to meet regulator's month-end deadline on UCC**

New Delhi: Bharti Airtel may have opened a window of relief for Indian mobile phone users by finding a way to back unwanted calls. The telco awarded a multi-million-dollar contract to US technology major IBM to deploy a blockchain-based pan India network which will allow the telco to protect its 284 million subscribers from pesky calls and messages, two persons familiar with the matter said.

"Airtel's consumers will have complete control over what messages they would want to get or block... the scope of mischievous will be considerably reduced, thereby curbing fake transactions and fraud," a person familiar with the matter said. "It is a reasonably significant sized contract."

The commercial deployment is already underway and both companies are expected to meet the regulator's orders on unsolicited commercial communications (UCC) set to come into effect before the month end, the second person said.

While the deployment will initially help Airtel curb pesky calls and messages, it will also help the operator in

Airtel did not offer comment on the deployment.

Last July, the Telecom Regulatory Authority of India (TRA) had overhauled rules to check spam calls and messages, directing telcos to use blockchain technology, and mandated subscriber consent to receive telemarketing messages. It also fixed shift penalties of between ₹1,000 and ₹50 lakh per violation in a month on telcos that do not comply with guidelines to check the menace.

# WhatsApp Tipline Gets 70k Requests to Verify Messages

New Delhi: WhatsApp received over 70,000 requests from people asking the company to authenticate messages they received after launching an India tipline number for this purpose a month ago, people familiar with the matter said.

The India tipline was set up as a research project to combat fake news during the general elections and was launched by Proto, an India-based media skills training startup. WhatsApp and Proto plan to finish the project and make the findings public by June, people familiar with the developments said.

It is not clear how many of these messages were debunked and how they have been addressed," said one person.

WhatsApp had said in April that the tipline would help create a database of rumours for the study of misinformation during the elections for Checkpoint, a research project commissioned and technically assisted by WhatsApp.

In a response to ET's queries, WhatsApp did not confirm or deny these estimates. "Addressing misinformation is a long term challenge and the research we supported during the election will guide our future efforts," a WhatsApp spokesman said. Proto did not respond to emails seeking comment till the time of going to press.

WhatsApp said in the first week of April that people in India could send unverified messages they received on their phones to WhatsApp number +91-9646-000-888 to be cross-checked.

Its ad news consultancy DigDeep.org Media and San Francisco-based Meedan, which builds digital tools for verification and fact-checking and has worked on projects like Electionland in the US and CrossCheck in France, were helping Proto in developing the verification and research frameworks for India.

New Delhi: Realty major DLF has reported a 76% jump in its consolidated net profit to ₹436.56 crore for the fourth quarter ended March, as its sales booking more than doubled to ₹2,436 crore in the last fiscal. Its net profit stood at ₹247.73 crore in the year-ago period, the company said in a regulatory filing late last night. Total income rose to ₹2,660.95 crore in the fourth quarter of FY19, from ₹1,845.92 crore in the corresponding period previous year. During the full FY 2018-19, net profit declined to ₹1,463.86 crore from ₹1,463.86 crore in the previous financial year. The drop in profit was because of exceptional gain from sales of residential business in 2017-18. -PTI
